In the past four editions (2010-2014) of the Politeia Forum we have analyzed the evolution of the concept of Corporate Social Responsibility (CSR), and the role of multinational corporations in the quest for global justice and then we have questioned the purpose of corporation.

The Eleventh Politeia Forum on “Debating the Future of Corporate Social Responsibility” aim to identify some of the issues facing responsible companies over the next decade. Among all the different issues, the Forum focus on the role of corporations about migrant’s integration, aware that this issue is a new area of work for CSR. In order to deal with this new challenge, it is necessary to increase capacity building at a number of different levels and better embedding CSR into the DNA of a business. The main topics of the Forum are: *“Immigration between politics and governance: which kind of integration?”* and *“Human rights and the social economic impact”*.

This edition of the Politeia forum is part of a series of conferences on “Destination Europe: How to Cope with the Migrant Crisis”, organized in 2015 by Politeia and Università degli Studi Milano.

The Forum is organized by the Research Centre Politeia in partnership with the University of Milano and is supported by a Promoting Committee of several well-known Italian companies. Aim of Politeia is to offer managers of national and international companies and experts in business ethics and CSR from the most prestigious national and international research centres the opportunity to discuss the emerging ethical issues in the global economic system, thus increasing the awareness and knowledge of the ethical and social responsibilities of economic organizations, and filling the gap between ‘practitioners’ and ‘experts’.
