Denis G. Arnold is the Jule and Marguerite Surtman Distinguished Scholar in Business Ethics in the Department of Management at the University of North Carolina at Charlotte. He received his Ph.D. from the University of Minnesota and is a past fellow of the U.S. National Endowment of the Humanities. His current research focuses on global labor practices, business and human rights, ethical issues in the pharmaceutical industry, and industry self-regulation. Arnold is the author of over forty articles as well as the forthcoming book *The Ethics of Global Business* (Blackwell) and the editor, or co-editor, *Rising Above Sweatshops: Innovative Approaches to Global Labor Challenges* (Praeger); *Ethics and the Business of Biomedicine* (Cambridge); *The Ethics of Global Climate Change* (Cambridge); and *Ethical Theory and Business* (Pearson). Dr. Arnold is an Editor-in-Chief for the leading academic business ethics journal *Business Ethics Quarterly*. He is also President of the Society for Business Ethics, the main professional organization for business ethics scholars in the United States.
